1. INTRODUCTION

Protecting the privacy of people who use this website is important to us. We strive to keep all information that you have provided to us confidential and we will hold this personal data ("Personal Data") private and secure and we will only use this Personal Data for the purpose(s) you have agreed to. The purpose of this Privacy Statement is to explain what Personal Data we collect about you, how that Personal Data might be used and how we protect your Personal Data and privacy.

2. WHAT DATA DO WE COLLECT?

If you are just visiting the Website, we do not collect any Personal Data about you. However, we may automatically collect information about your visits, such as browsing patterns, the name of your Internet service provider; the Internet Protocol (IP) address through which you access the Internet; the date and time you access the Website; the pages that you access while visiting the Website; and the Internet address of the website from which you linked directly to our Website. Information collected in this way does not reveal your contact details or any type of Personal Data. This information is only used in aggregate form manage and develop the Website and is not linked to any individual's Personal Data.

If you register for our newsletter then we will hold and store your email address. Our newsletter is sent out by the Festival and we will not pass on your email addresses to third parties.

If you purchase Nozstock: The Hidden Valley tickets at www.nozstock.com then your personal details will be held on our behalf by our nominated ticket sales agents for the purpose of providing this service ("Service") to you. If you opt into our newsletter they will export your email address and name to us so we can send you newsletters. The Personal Data collected by us will include your full name, e-mail address, address, country of residence and postcode for you. From time to time you may also provide other Personal Data which we need to provide you with this Service you request, such as your credit card details. If you are successful in any application for a ticket for the Festival then the necessary Personal Data to allow your ticket to be allocated will be provided to our ticketing service providers who will use this information only for that purpose. You will receive updates about the future Nozstock Festivals but we will never pass on your information to a third party.

If you register for hospitality tickets (the Service) then we will ask you to provide us with Personal Data that will include a company name, your personal name, address, email address and mobile telephone number. This Personal Data will be held by us to provide you with the Service and by requesting hospitality tickets your details will be automatically stored so an application form can be sent to you to provide the service in a subsequent year. If you do not want the service in subsequent years then you can email enquiries@nozstock.com and ask for your Personal Data to be deleted and this will be done within fourteen working days.

If you have entered a Nozstock: The Hidden Valley competition then we will ask you for and keep the Personal Data you have provided including your name, personal contact details and email address. We hold this information to provide these services (each the "Service" and together the "Services") including providing details of the Services and the rules and results of any competitions. If you

provide photographs for any public gallery on the website we will ask you for and will keep Personal Data including your name and your email address. This data will only be held to communicate with you about the use of your photographs. All information will be deleted as soon as possible once it is no longer needed to provide Service to you.

3. HOW DO WE USE PERSONAL DATA?

We may use personal information for: administrative, operational and marketing purposes and to communicate with you about your use of the Services any changes to the Services. We reserve the right to access and disclose Personal Data to comply with applicable laws and lawful government requests or requests by the police investigating suspected illegal activities, to operate our systems properly or to protect ourselves or other the Website users. This website does not host any public forums or message boards but please remember that any Personal Data that you disclose on such sites become public information and you should exercise caution when deciding to disclose any information on them.

4. HOW DO WE PROTECT MEMBERS' PERSONAL DATA?

We do our best to ensure that your personal information is secure. As required by UK data protection laws, we follow strict security procedures in the storage and disclosure of information which you have given to us. However, the Internet is not a secure environment and we cannot guarantee the security of any information which you send to us. We do not provide Personal Data to third parties (save for our authorised ticket sales agents) unless that is required under any applicable law or to fulfil any Service you have requested. We will only pass on your information to other companies if it is necessary to perform the Services or with your prior consent.
